## Reserved Words in the Macro Facility

The macro facility reserves the words listed in Table A1.1 on page 285 for internal use.

- Do not use a reserved word as the name of a macro, a macro variable, or a macro label. Reserved words include words reserved by both the macro facility and the operating system. When a macro name is a macro facility reserved word, the macro processor issues a warning, and the macro is neither compiled nor available for execution.
- Do not prefix the name of a macro language element with SYS because the SAS System reserves the SYS prefix for the names of macro language elements supplied with SAS software.
- Do not prefix macro variables names with SYS, AF or DMS, to avoid macro name conflicts.
